For example:

H1129/150 means product H1129 in a pack of 150.

The number after the oblique stroke (/) is the quantity of the product in the pack.

To order 600 pieces of H1129 — Please supply H1129/150, quantity 4 packets.

To order 50 pieces H1129 — Please supply H1129/25, quantity 2 packets.

Many Utilux products are available in reels in which case the letter "R" is used to denote reel which appears directly after the oblique stroke.

Please follow these simple ordering instructions to ensure the smooth processing of your order.

Please Note: Standard pack sizes will not be broken.

GENERAL CONDITIONS OF SALE

1. FREIGHT

All orders above \$50 list will be delivered free into store by Utilux nominated carriers. Where other carriers or courier delivery is requested all charges will be to the customers account.

2. PAYMENT

Strictly nett, 20th of month following date of despatch.

3. MINIMUM QUANTITY

- (a) For small loose piece terminals 100 pieces per type.
- (b) Standard pack sizes will not be broken. Where bulk prices are quoted these apply to quantities above the maximum standard pack.

4. PRICES

Unless previously negotiated, prices shall be those ruling at date of despatch. While every endeavour will be made to give notice of price changes, we reserve the right to change prices without notice.

5. RETURNED GOODS

RETURNS WILL NOT BE ACCEPTED WITHOUT PRIOR APPROVAL. A Return of Goods Authority number must be quoted together with the relevant invoice number to facilitate prompt handling of credits. Returns due to customer error will only be accepted in exceptional circumstances, when a restocking fee may be charged.

6. CLAIMS

Claims arising from incorrect supply or shortages must be made within 7 days.

Claims arising from incorrect charges must be made within 30 days.

Claims arising from late delivery will not be accepted.
