CONDITIONS OF AUCTION

(d) This Title Warranty shall determine the full extent of Turners obligations for any defect of Title and Turners shall not be liable for any consequential or other loss sustained by the purchaser nor shall it be liable for any improvements to the vehicle or loss of use of the vehicle or expenses incurred with respect to the vehicle and on settlement by Turners, Turners shall be absolutely released and discharged from all obligations to the purchaser with respect to this Title Warranty.

(ii) Description Warranty

(a) Turners warrants that the following particulars given for motor vehicles sold at auction will be correct:

- (i) Year of first registration in New Zealand;
- (ii) CC rating;
- (iii) Number of registered non LMVD New Zealand owners according to certificate of registration shall not be more than stated;
- (iv) New Zealand/ex Overseas used import;
- (v) Make and model;
- (vi) The accessories listed with the vehicle to pass with the vehicle;
- (vii) Registration licensing particulars;
- (viii) Warrant/Certificate of Fitness particulars;
- (ix) Odometer Reading according to documented history (except that no warranty is given concerning the accuracy of odometer readings on any vehicle)
- (x) Road Users charge paid up to current odometer reading.

(b) In the event of there being a variation of particulars given by the auctioneer at auction and the particulars listed in any advertising or in the sale catalogue then the details given by the auctioneer shall prevail.

(C) Warranty Claims

- (i) The Title Warranty is valid for an indefinite period subject to the provisions of condition 14(B)(i).
- (ii) The description warranties are valid for a period of sixty days from the date of the auction sale.
- (iii) Any claim under the description warranties must be made by notifying Turners in writing within a stipulated sixty days from date of auction.
- (iv) Notice shall be deemed to have been properly given if delivered to the branch where the auction sale took place.
- (v) All warranty claims must set out full particulars of the breach complained of and the warranty relied on by the purchaser.

(D) Purchaser's Rights for Breach of Warranties

(i) Purchaser's rights on breach of the Title Warranty shall be as set out in clause 14(B)(i).

(ii) With respect to the breach of the Description warranties, Turners may at its sole discretion;

- (a) Take such steps as may be necessary to remedy the breach;
- (b) Reach a settlement with the purchaser on terms satisfactory to the purchaser;
- (c) Refund the purchase price.

(iii) With respect to a breach of any condition warranty, Turners may at its sole discretion:

- (a) Take such steps as may be necessary to remedy the breach;
- (b) Reach a settlement with the purchaser on terms satisfactory to the purchaser;
- (c) Refund the purchase price.

(iv) If Turners and the purchaser do not agree on whether there has been a breach of the condition warranty, the issue will be determined by an independent A grade mechanic appointed by the President of the Motor Trade Association whose determination in this respect shall be final and binding on both Turners and the purchaser.

(E) General Conditions relating to all Warranties

(i) The warranties given by Turners under its Purchase Protection plan are the only warranties given by Turners.

(ii) All vehicles are otherwise sold as is where is and no warranties are given as to merchantability or fitness for purpose or quality or condition or otherwise howsoever.

(iii) All parts and accessories sold with vehicles are sold as is where is and no warranties are given as to merchantability or fitness for purpose or quality or condition or otherwise howsoever.

(iv) Turners shall not under any circumstances be liable for any consequential loss or damage, costs or expenses incurred on motor vehicles by purchasers and the purchaser's only rights shall be those expressly given to them by the title, and description warranty as set out in clause 13B hereof.

(v) If Turners elects to refund the purchase price to any purchaser it shall only do so on the return of the vehicle to Turners in the same condition as the vehicle was at the date of auction sale and upon Turners receiving a valid notice of change of ownership executed by the purchaser as owner. Turners will proceed to sell the vehicle on the purchaser's behalf and recoup from the proceeds of such sale the purchase price refund paid by Turners to the purchaser.

15. In certain circumstances a vehicle may be sold with a "Vendor Warranty". The terms of such warranty shall be as appear in Turners Vendor Warranty Brochure current at the time of purchase. Unless it is clearly stated at the time of auction that the vehicle carries a vendor warranty the only warranties given on any vehicle are those contained in clause 13 herein.

Road User Charges

16. In the case of vehicles not covered by Turners Purchase Protection plan and where road user charges apply it is up to the purchaser to determine any unpaid charges as Turners Auctions LTD accepts no responsibility for any outstanding charges. Turners Auctions Limited may elect to waive this condition in consideration of making a charge against the purchaser. In such circumstances an announcement will be made prior to the commencement of the auction.

Pre Auction Mechanical Reports

17. Where Turners elect to provide Pre Auction Mechanical Reports purchasers are to be aware that these reports are to be used only as a guide to assist in assessing vehicles. No warranty is expressed or implied. The final responsibility for assessing the condition of any vehicle rests with the bidders prior to the commencement of the auction.

Damages

18. Any purchaser, prospective purchaser or person who causes damage to any item or vehicle either before or after that item or vehicle has been auctioned will be required to pay for either the repair or replacement necessary to put good that damage.

Motor Vehicles or Plant which may be Driven on a Road

19. Where any vehicle sold by the auctioneer does not at the time of delivery have a current certificate of fitness or permit or a warrant of fitness issued with respect to the vehicle within one month before the date of the auction sale the purchaser shall supply to the auctioneer at the time of delivery an undertaking in writing as provided for in Regulation 86(2)(b) of the Traffic Regulation 1976.

20. Every purchaser must supply to the auctioneer before taking delivery of a vehicle the information necessary to enable the Change of Ownership to be registered. (Turners Auctions reserves the right to delay release of vehicle/goods until this is done.) The transfer fee which is payable by the purchaser is normally included in the T.P.P. charge. Any variation to this will be announced prior to auction.

21. The purchaser accepts all responsibilities associated with the registered ownership of the vehicle/goods.

22. The certificate of Registration of Motor Vehicle will be forwarded to the purchaser after change of ownership has been registered. Any necessary licensing or re-registration is the responsibility of the purchaser.

23. No vehicle may be driven on a road unless it complies in all respects with the Transport Act 1982 and regulations made hereunder and the purchasers shall be responsible for complying with these requirements.

24. The attention of purchasers is drawn to the Motor Vehicle Dealers Act 1975, particularly sections 4 and 7 of the Act.

Withdrawal Fee

25. Where a vendor (seller) books a vehicle into auction for sale and then withdraws the vehicle within 12 hours prior to the auction taking place, the vendor will be charged \$150 withdrawal fee.

Exclusion of Auctioneer's Liability

26. Except as expressly provided herein, in the case of any dispute any remedy of the purchaser shall be against the vendor only and under no circumstances including an action for breach of any fundamental obligation shall any remedy lie against the auctioneer or any agent or employee of the auctioneer.

Additions and Modification of Conditions

27. Turners Auctions Limited reserves the right to add additional conditions of sale to any sale it conducts. It also reserves the right to modify or withdraw any of the above conditions. In such circumstances, additions, modifications or withdrawals will be announced at the commencement of the auction or any time during an auction.

Definition

28. In these conditions the word "auctioneer" includes Turners Auctions Limited and any person authorised by it to conduct the sale.

29. In these conditions Turners shall mean Turners Auctions Limited.

CONDITIONS OF AUCTION

These conditions when exhibited in the auction rooms or any place where an auction is being conducted shall be binding upon both vendor and purchaser upon the auctioneer announcing that the sale is conducted subject to these conditions so exhibited notwithstanding that the auctioneer may not have read them aloud and any such announcement may be made by the auctioneer at any time during a sale.

Disclaimers

1. Subject to the express warranties contained herein in clause 14 and to any statutory warranties that may apply to motor vehicle dealers selling motor vehicles by auction, all vehicles/goods are offered as is, where is. No allowance for any error in weight, size, quality or fitness or any defect, imperfection or error whatsoever will be made. No express or implied warranties are given as to the condition, mileage or description of the vehicle/goods notwithstanding any description in any published catalogue or advertisement. No representation is made by Turners Auctions Limited or the seller as to either the distance travelled or the accuracy of the odometer reading for any used import vehicle. Turners Auctions do not guarantee the odometer or clock reading on any vehicle. No representation is made as to the past use of any vehicle. Turners do not guarantee the odometer or clock reading on any vehicle. No warranty given as to weather the vehicle has suffered flood or water damage, structural, chassis or other repair.
2. The purchaser must be satisfied as to the actual condition of its vehicle/goods prior to commencement of bidding. By the act of bidding the purchaser shall be deemed to have inspected the vehicle/goods purchased and to have accepted the same in their then condition in all respects.
3. Where the certificate of registration is not available at the time of sale Turners Auctions may check the vehicle history with Motor Registration. Turners Auctions do not guarantee information provided by Motor Registration nor can it guarantee that the history is complete.

Registration of Purchasers

4. Unless otherwise agreed by the auctioneer all intending purchasers must register at the auctioneer's office prior to commencement of bidding. Each purchaser must supply on registration full details requested before a buyer's number will be issued. The auctioneer reserves the right to request identification from or deny registration to any intending purchaser without giving any reason.

Conduct of Sale

5. All lots are offered for sale subject to:
 - (a) any reserve price set by the vendor or vendor's agent;
 - (b) the right to bid on behalf of the vendor or vendor's agent where applicable;
 - (c) the right to bid on behalf of an absentee bidder.
6. The highest bidder shall be the purchaser once the reserve has been achieved or exceeded. If any dispute arises the auctioneer shall have absolute discretion to settle it and/or to put any disputed lot up again. The auctioneer has full discretion to refuse any bid, to divide any lot, to combine any two or more lots, to withdraw any lot or lots, (whether or not the reserve has been reached) or to change the order of sale shown in the catalogue without in any case giving any reason. Any decision made under the provisions of this clause by the auctioneer shall be final and binding on all parties.

Purchase Price - G.S.T. Status

7. At auctions held on Turners Premises all lots are sold INCLUSIVE OF GOODS AND SERVICES TAX except if announced to the contrary by the auctioneer prior to the sale. Where auctions are held on premises other than Turners the auctions are conducted predominantly GST exclusive unless stated contrary to this prior to the commencement of the sale. In both situations purchasers will be issued a tax invoice.

Payment of Price

8. On the fall of the gavel or any other similar act, which concludes the bidding the buyer shall have entered into an unconditional contract to purchase the vehicle/goods, the terms for which are net cash. All payments must be in cash or by bank cheque. Finance may be available in accordance with clause 9 below.
9. Turners may act as accredited introducers for suppliers of finance, insurance and warranties.
10. Turners may charge a **buyer premium** on items sold at auction. In such circumstances, details of such charges will be announced prior to the commencement of the auction. At vehicle auctions Turners may make a compulsory buyers charge called **T.P.P.** (Turners Protection Plan). In such cases the amount of this charge, which may vary for different vehicles, will be announced prior to the commencement of the auction.
11. All vehicles/goods shall as from the fall of the gavel be at the risk of the purchaser who shall pay for and remove the same from Turners premises or sale site on the same day as the sale, in default of which Turners shall not be responsible for the vehicles/goods if lost, stolen, damaged or destroyed whether or not there is any negligence on the part of Turners or any agent of Turners. Any lot not so removed shall be at the sole risk of the purchaser and Turners may make a reasonable charge for storage. No vehicles/goods may be claimed or removed until the sale has been concluded. If for any reason whatever the purchaser fails to complete his purchase on the day of sale or deadline specified prior to auction, it shall be optional for Turners without notice to:
 - (a) re-sell the lot privately or by auction and/or;
 - (b) sue for the balance of the full purchase price of the lot without any notice or demand to the purchaser and/or;
 - (c) cancel the contract and forfeit the deposit (if any) and/or;
 - (d) charge the purchaser interest at a rate not exceeding 20% per annum on any part of the purchase money unpaid by the purchaser as aforesaid from the date of sale until actual payment. In the case of a re-sale pursuant to this paragraph Turners shall be under no liability either to the vendor or the purchaser for any loss that may occur nor shall the purchaser be entitled to any increase in the price that may be received but the purchaser shall if called upon make up any deficiency in the price obtained on any re-sale;
 - (e) charge the purchaser for all costs involved in recovering unpaid monies.
 - (f) charge the purchaser a fee of \$250 plus G.S.T. additional to the purchase price for presenting Turners a cheque which is subsequently dishonoured.

Credit Terms

12.
 - (i) From time to time, Turners may offer at its sole discretion, credit payment terms to selected clients.
 - (ii) That under the terms of the Privacy Act (1 July 1993) that the purchaser authorises any person or company to provide Turners with such information as it may require in response to its credit enquiry's. That the purchaser authorises Turners to furnish to any third party details of an application and any subsequent dealings that the purchaser may have with Turners as a result of an application being actioned by Turners.
 - (iii) That the purchaser undertakes to pay the account in full on or before the due date. In default of such prompt payment the purchaser undertake to pay interest on any outstanding amount at the rate of 2% per month and to indemnify Turners and pay collection costs plus all costs and expenses on a solicitor/client basis which we may incur recovering from the purchaser on any overdue account.
 - (iv) The debtor gives Turners the right to enter any property to up-lift the said goods in the event that payment of the said goods has not been made.

Title to Vehicles/ Goods

13. Lots sold will not become the property of the purchaser until full payment is made. Payment by cheque is not made until clearance of the cheque. Turners reserve the right to withhold delivery of vehicles/goods purchased until the above conditions have been met. Vehicles/goods which have not been paid for in full may at any time be repossessed by or on behalf of the seller or the auctioneer and representatives of the seller or the auctioneer may at any time go into any premises where the vehicles/goods are present for the purpose of effecting repossession.

Turners Purchase Protection

14.
 - (A) **Vehicles Covered by Warranties**
 - (i) The following title and description warranties shall extend to all motor vehicles sold by auction unless expressly excluded or modified by the auctioneer before or during the course of the auction.
 - (ii) A warranty fee shall be payable by the Purchaser with respect to the purchase of any vehicle that is covered by Turners Purchase Protection and the amount of the fee will be announced prior to the auction.

(B) Nature of Warranties

- (i) Title Warranty
 - (a) Turners' vendors warrant to Turners that good Title will pass to the purchaser. If at any time in the future it is established that the vehicle sold at auction was not at the date of the auction sale unencumbered or if the vendor did not have Title to the vehicle or was not authorised to sell the vehicle as at the auction date. Turners will at its sole discretion either take such steps as may be necessary to give the purchaser good Title to the vehicle or refund the purchase price.
 - (b) This Title Warranty is subject to the express condition that in the event of Turners electing to refund the purchase price, the purchasers will if able to do so, return the vehicle and its registration papers to Turners within seven days from the date Turners advised the purchaser of its intention to refund the purchase price and if the vehicle is not returned within this time Turners will be released from any further obligations with respect to this Title Warranty and this Title Warranty shall not be enforceable against it. This Title Warranty is subject to a further condition that the purchaser will assign to Turners upon request any rights it has against the vendor or any other party in connection with the purchaser's purchase of the vehicle and the purchaser will fully co-operate with Turners in enforcing such rights.
 - (c) This Title Warranty is conditional on the purchaser advising Turners immediately of any claim made against the vehicle by any party claiming any interest in it, and the purchaser otherwise not releasing the vehicle into the possession of any third party and not otherwise compromising any claim or agreeing to settle any claim without Turners' authority. If the purchaser breaches this condition Turners shall be deemed to be released from all obligations under this Title Warranty.
