
#### Overview



- 1. Menu/select: Opens, selects or exits the OSD menu.
- 2. "-"/Auto: Navigates backward through the OSD menu and decreases adjustment levels; when the OSD menu is inactive, activates the auto adjustment feature to optimize the screen image.
- **3.** "+": Navigates forward through the OSD menu and increases adjustment levels.
- **4. Power LED**: fully powered = green; sleep mode = amber; sleep timer mode = flashing amber.
- 5. **Power**: Turns the monitor on or off.
